

Correcting the Gender Marker on NYC-Issued Birth Certificates: A Provider's Guide

The requirements for correcting the gender marker on a NYC birth certificate have changed. Surgery and a name change are no longer required. Instead, applicants must provide an affirmation/affidavit from a US-licensed medical/mental health provider.

-Please note these guidelines are applicable only to NYC-issued birth certificates.-

Application Process

- •Submit a completed Birth Correction Application form (VR-172), available at http://www.nyc.gov/html/doh/html/ services/vr-birth-correct.shtml
- •Provide a signed affirmation/affidavit from one of the following US-licensed providers listed below.
- •Submit a photocopy of current, signed photo identification *and* a check or money order for \$55 (\$40 processing

fee plus \$15 fee for new certificate) made payable to the NYC Department of Health and Mental Hygiene. Walk-in customers may pay using a debit or credit card.

An affirmation or affidavit can be signed by a US-licensed provider:

- •Physician (MD or DO);
- •Doctoral-level psychologist (PhD or PsyD in clinical or counseling);
- Social worker (LMSW or LCSW);
- Physician assistant;
- Nurse practitioner;
- •Marriage and family therapist;
- •Mental health counselor; or
- •Midwife.

Affirmation/Affidavit should include:

- •Professional credentials; and
- Statement that, in keeping with contemporary expert standards regarding gender identity, the applicant's requested change of sex designation of male or female accurately reflects the applicant's gender identity.

- •Affidavits provided by practitioners other than MD / DO must be notarized.

How Providers Can Help

•Share this information with NYC-born transgender patients/clients and spread the word among your professional networks.

- •Support patients/clients by assisting with the affirmation/affidavit. This may involve reviewing an applicant's medical history and affirming/attesting to their gender identity.

These guidelines are applicable only to NYC-issued birth certificates.



Guidelines to Having Affirming Conversations with Transgender Clients

- Ask people what they would like to be called, and then call them that.
- Call transgender people by their preferred name, even if it doesn't match their documentation.
- Use the pronoun (he/him/his, she/her/hers, or something else) that the client prefers.
- It's always important to ask, "Do you want me to use your preferred name only in private, or only with specific people! If so, which people!"
- If you accidentally use a wrong name or pronoun, apologize, use the right name or pronoun, and move on.
- These pointers work well with all clients. With transgender people, they signal safety and respect.
- If a client requests evaluation or medical treatment for gender transition, refer them to a provider that specifically serves that community, such as those listed below.
- If you are a licensed medical or mental health provider, you
 may assist transgender individuals with correcting the
 gender marker on their NYC-issued birth certificate. See
